## ZEROING IN ON YOUR VICE PRESIDENT By Joe Vavra

I was drafted in March of 1943. After Basic Training (Combat Engineers) and a tour (two terms) of ASTP at Catholic University in Washington, DC, I was sent with many others to Camp Swift in 1944.1 was assigned to the Third Platoon, Company C, 406<sup>th</sup>, Regiment as an assistant BAR man. From Camp Swift, the division went to Fort Dix and Camp Kilmer before shipping out to Europe on the Sea Tiger. My tour of duty with the Ozarks ended on November 20, 1944 when I was wounded in Geronsweiler.

After a short hospital stay in Paris and Wales, I was shipped to Madigan 'General Hospital in Tacoma, Washington, and O'Reilly General Hospital in Springfield, Missouri for further treatment. I was discharged in April of 1946. I married Dolores Kipta in 1945. We have two daughters, a granddaughter and one great-granddaughter so far.

I went to Illinois Institute of Technology in Chicago and pursued a career in Civil Engineering, working at Shell Oil, Wisconsin Electric Power and Sundstrand Aviation. I was also self-employed in the construction industry for several years.

In addition to serving as vice president of the association, I am the 406<sup>th</sup> Regimental Coordinator and C Company Coordinator/Newsletter Editor.

My wife Dolores and I have enjoyed many of the 60 Ozark Reunions. Our first was in St. Louis-1950, then Detroit-1952, Chicago-1953 and Harrisburg-1974. From 1988 until the Final Reunion we attended all but Hampton Beach-1995 and San Francisco-1997.

#### 1989

Frank Alfiero, resigns as Secretary-Treasure of the 102nd Association. Frank is only the second individual to hold this post in the 44-year history of the association. He took over in 1984 upon the death of Abe Mitchell, who became secretary-treasurer when the Association was formed in 1948. Frank served during a period when the association enjoyed its greatest growth.

## Minutes of Membership Meeting At Final Reunion in Cincinnati

The regular membership meeting of the 102nd INFANTRY DIVISION ASSOCIATION, INC. was held at the Sheraton Cincinnati North Hotel, Cincinnati, MO, on the 30th day of August 2008 at the hour of 10:00 a.m.

President Doane F. Blair called the meeting to order. The Pledge of Allegiance was led by Vice President Joe Vavra.

The president called on Bob Enklemann to read an e-mail from Jan and Army Senden of Schindveld, Holland. This couple has attended 102<sup>nd</sup> Association Reunions. They are two of the caretakers of the graves of 102<sup>nd</sup> Division soldiers buried at the Margratten Military Cemetery in Holland. They expressed sadness on seeing the association's dissolution, but said they understand the reason it is being done. They also said they will be forever grateful for their liberation from Nazi occupation by the Ozarks. Enklemann also mentioned a possible mini-reunion in Branson, Missouri in 2009.

The president announced that Past President and Historian Richard L. Riemer will be Parliamentarian for the meeting. President Blair introduced the members at the head table.

Riemer was asked to discuss the dissolution process. He reported that the Executive Committee had met and that, in accordance with the by-laws, all active members of the Association had been advised of the proposed dissolution. He said the Committee is proceeding with the dissolution process. The State of New Jersey will be consulted and asked for instructions on action that will meet its requirements. In addition, the Internal Revenue Service will be notified of the dissolution.

Riemer also announced that a TRUST to be known as the 102<sup>nd</sup> Infantry Division Association Memorial Scholarship Trust is in the process of being established. This Trust will be accepted as a tax exempt entity by the Internal Revenue Service. The purpose of the Trust is to manage the scholarship funds, select qualified applicants, and award scholarships to those selected. The Trustees appointed by the Executive Committee were Robert Enklemann, James Alspaugh and General Wilson Reed.

The scholarships awarded for 2008 will be paid from the Association funds. When all financial obligations of the association have been met, the remaining funds will be transferred to the 102<sup>nd</sup> Infantry Division Association Memorial Scholarship Trust.

Any and all unforeseen expenses, taxes, fees that may arise after the funds have been transferred will be paid by the Trust.

He said he will provide a package deal that will include hotel accommodations, transportation for tours, shows featuring nationally popular entertainers, most meals, a trip to the veteran's museum, and a trip to the Branson Belle Showboat, as well as a farewell sit-down dinner.

WWII Ozarks shared lots of stories in the Hospitality Room each night, at meals, or on buses enroute to tour sites. They talked about the boredom of a static front line in foxholes, bunkers or cellars. They talked a little about advancing against enemy fire in attacks or defending against enemy assaults. They also talked about good times — the rare trips to showers, an occasional pass (if they were lucky) to Paris, Switzerland, the Riviera or London. Family members listened attentively as veterans shared their memories.

Associate member Barbie Bowman suggested that some of the younger associates establish a new 102<sup>nd</sup> Infantry Association. However, no action was taken on her suggestion as a hotel fire alarm sounded. When a second alarm sounded moments later, President Doan Blair declared the meeting adjourned and members evacuated the meeting room. A few minutes later the hotel staff announced that it was a false alarm — no fire.

#### CROSSINING THE ROER GET-TOGETHERS

For 29 years, George Hagerty (927FAHQ) chaired the planning and production of an annual "Crossing the Roer" memorial get-together in Lancaster, Pennsylvania. General Wilson Reed was usually a keynote speaker at the gathering, and Ozarks from around the U.S. met to remember that mornin<sup>g</sup> of February 23, 1945.




The division history "With the 102d Chairman George Hagerty Infantry Division Through Germany", describes that morning as follows:

"The valley of the Roer was ablaze with the fire of exploding shells and tracers. One wondered how anything could live under the devastating impact. A paper could be read under the glare of artillery muzzle flashes and the brilliance of bursting shells. The din-deafened troops scurried down the steep bank to waiting boats. Clouds of smoke and the aroma of burning powder drifted over the valley in ever-increasing volume. The long expected of fensive was actually under way."

The memorial meeting was always held in February. The first one was in 1974, and the last one was in 2003. It regularly drew large numbers, considering the location and time of the year. One participant said "war-time experiences, latest news of comrades, and pitchers of beer were always plentiful."

Several Ozarks living in Pennsylvania assisted Hagerty, including the Fenstermachers and the Emerichs.

## A FIRST TIMER LOOKS BACK AND SHARES HIS FEELINGS

As a "first timer" attending the 60th and Final Reunion of the 102<sup>nd</sup> Infantry Division Association, everything was fresh and new to me — the names, the faces, the stories and even some of the jokes. Driven by a desire to share time with my dad at an event that made his face light up whenever he talked about it, I was not sure what to expect. Would I be trapped with a bunch of cynical old men filled with bitterness who felt underappreciated by younger generations? Not even close.

From my first encounter in the shuttle ride from the airport, my first new veteran friend had that same sparkle in his eye and big smile on his face as I had seen in my dad, and the same cadence in his voice as he and his wife talked enthusiastically. What I found were some of the brightest, most hospitable, fun loving, positive, highly successful and proudest family of people that I have ever had the pleasure and privilege of being around. Some of the bodies may not have been as nimble as they once were, but the minds were sharp, the memories vivid, the sense of humors keen, and the aura of respect overwhelmingly prominent.

As I tried to visualize the personalities that I met digging trenches in the frozen ground from foxhole to foxhole, or sweeping for land mines, or lying motionless in the mud wondering if they would see their next birthday, the obvious became even more apparent to me. This experience not only shaped their lives, maturing them beyond their years, whether they wanted it to or not, but the experience shaped all of our lives — both as part of their immediate families touched directly by these remarkable men and as citizens of this great country they so successfully represented and whose rights and freedoms they upheld.

All of us have so much for which to be thankful. I have always been thankful for my dad. I am truly blessed to be his son. And I have always been thankful for his service to his country and all of the others unknown to me who served with him. Now this family of brave men has a face for me, and what a handsome and glorious face it is. My memory will always include the eyes that smiled on me, the handshakes that so sincerely greeted me, the pride evident in the numerous widows, children and grandchildren in attendance, the stories of wartime letters and snapshots, the birthdays celebrated and the birthdays that could only be remembered, and the overall genuine excitement of being together one last time to "enjoy yourself, renew old acquaintances, meet and make new friends".

To borrow from one of the more clever TV commercials of our current day, allow me to summarize my feelings this way —

A visit to the National Museum of the United States Air Force.... priceless.

Attending a Major League baseball game with your 84-yearold dad.... priceless.

Hearing a 15-year-old sing the National Anthem in honor of her grandfathers .... priceless.

Being a proud member of the Ozarks family.—PRICELESS.

Thank you for being there, then and now. May God continue to bless you.

## Ozark Scholarship Trust to Administer Program

A Trust to be known as the 102<sup>nd</sup> Infantry Division Association Memorial Scholarship Trust is in the process of being established, Past President Richard Reimer announced at the membership meeting on August 30. It will manage the scholarship funds, select qualified applicants and award scholarships in the future.

Trustees appointed by the Executive Committee are Robert Enkleman (405-H), James Alspaugh (406-1) and General Wilson Reed (102 HQ).

The Trust will function much as the Scholarship Committee has in the past as the 102<sup>nd</sup> Infantry Division Memorial Scholarship Program, Alspaugh commented. The Trustees will be responsible for the Trust, but they will continue to consult with members of the committee, he added. Alspaugh has served as committee secretary, has been the contact for applicants for scholarships, and has overseen the process of selecting scholarship winners.

The committee will continue to rely on the present judges, who have been asked to continue to serve. In addition, he said, there will be ex-officio members who will advise and carry out special duties of legal, financial, and communication nature.

These ex-officio members were officers of the soon to be dissolved association.

Members of the committee are Gen. Reed, chairman; Enkleman, assistant chairman; and Alspaugh, secretary. Judges are Robert Joy (379 FA-C), Bill Kamsler (405 HQ), John Ledbetter (405 HQ2), W. G. Bill Reist (407-K), and Lynn Freeman (406-A). Ex-Officio members are Richard Ditton (405-L) and Ralph Baringer (406 HQ2).

The committee currently has one opening for a judge, Alspaugh said. He invited anyone interested in serving in this capacity to submit a short resume, which should list experience in evaluating personnel. If interested, contact Gen. Wilson R. Reed, 6383 Vale Street, Alexandria, VA 22312-1436.

There was discussion from the floor as to whether or not the Internal Revenue Code was being followed to insure the Trust would be tax exempt. He also stated that copies of the 12 pages of the actions taken will be sent to all the present Executive Committee and to all other interested parties.

The Secretary read the minutes of the August 2007 General Meeting. Past President Bob Smith stated that the minutes were in error — that he had voted "no" on the motion to dissolve the association. The secretary was instructed to amend the minutes to show this correction. Motion by Bob Enkleman to accept the minutes as amended was seconded by Ed Blackburn, and the motion passed.

The treasurer, Ralph Baringer, was asked for his report. Ms. Mel Baringer gave the report for the treasurer. A copy of that report is attached as an addendum to these minutes.

General Reed was asked for a report from the Scholarship Committee. He announced that 20 applicants had been selected and that they would be receiving checks of \$1,000 each in the next few days. The names of the recipients will be announced at the banquet this evening.

The last page of the Division History -- "With the 102nd Infantry Division Through Germany" — has a meaningful farewell message and pledge. Your editor suggests we adopt it as our farewell message for this final issue of the Ozark Notes.

"The 102<sup>nd</sup> Infantry Division had seen history in the making and had made history. In future years Ozarks will think back to those long years of training, the grueling convoys, the wet weeks in green Normandy. A corner of their hearts will always hold memories of the hospitable Hollanders and their spick-and-span coal-mine baths.

They will marvel at the courage which forced green troops swarming over Tiger Royals in the thunderous battle of Immendorf. They will recall with pride and a twinge of regret for fallen comrades, their great victories — the Roer crossing, the push to the Rhine, the Wesergebirge, the dash to the Elbe. They

will recount with a pang that such things should happen in a civilized world — that over 4,000 enemy fell against them, that 147,000 more were captured. They will reflect on the miseries and destitution of a once proud people, now humbled amid their ruins and dead. And they will become more determined that those immortal words stemming from an earlier conflict shall assume a new prophetic meaning, not only for 'this nation,' but for the world.

(....that from these honored dead we take an increased devotion to that cause for which they gave the last full measure of devotion; that we here highly resolve that these dead shall not have died in vain; that this nation under God, shall have a new birth of freedom; and that government of the people, by the people, for the people, shall not perish from the earth."
